2025/06/09/01 **PUBLIC QUESTIONS**

2025/06/09/04 **PROGRESS REPORT**

(1) Park Improvements

The Clerk advised that a new steel storage container had been delivered as part of the FA machinery grant application that was still ongoing and could not be concluded until the new machinery had been delivered and invoiced.

A second stage of an ecology survey was to be undertaken at the pond area of the park which would identify some of the wildlife in existence and the impact on pond area improvements.

The decision on the planning application for new a football changing room was awaited but there had been an indication that no problems were foreseen.

Following general discussion, it was **RESOLVED** that the information given be noted and further progress be awaited.

(2) <u>Summer Activities</u>

The Clerk advised that fun and food grant details from Durham County Council had now been released and a single application had been submitted in the name of the Association but based on joint arrangements with Hutton Henry and Station Town Parish Council. The Clerk advised that the application could include the park area but mainly the Community Centre with a more detailed report to be presented at the next Association meeting.

The Clerk advised that the Children in Need CIC which had been set up to become the tenant of the former Park Keeper's Cottage at the park so that nursery provision could then be undertaken from the building wished to terminate the lease because it was to cease to operate. The operators of the Nursey, the Wingate Childcare CIC wished to take over the lease.

- a) It be agreed that the Nursery Cottage lease be transferred to the Wingate Childcare CIC; and
- b) The transfer be at no cost to the Parish Councill and so the Wingate Childcare CIC be responsible for the Parish Council's legal fees associated with the transfer.

a) <u>Proposed Change of use of 21 Arundel Walk, Wingate from a</u> Dwelling House to a Children's Home.

Consideration was given to a proposed planning application for the change of use of a dwelling house at 21 Arundel Walk, Wingate to a children's home. It was also noted that a public meeting had recently been arranged by a County Councillor representing Wingate at which there were significant public objections to the proposals.
